Trenched a hole for the exterior water fountain

Lightening took out a transformer and controller on clock 3.

Lightening also has created a variety of shorts within clock 2, we are looking through zones and solenoids to make repairs.

Graffiti was sprayed all over the pavilion. It has been cleaned up.

Cornhole tournament at the park had 70 teams.

Preparing for BMX state race.

Adding another lax tournament to the list of events for Oct 9th and 10th. This will be combined with the pumpkin patch.

We will be having a staff meeting on Thursday to start discussing budget items for 2022. Ice rink will be delivered in the next 2 weeks and stored at the park for installation in October

Outdoor services sprayed areas on the turf that were being taken over by noxious weeds.

Fall tree care has been performed.

Bushes are being trimmed in the parking lots.

A new trail has been installed that connects the bike parking lot to the beginner section of the bike park.

Native weeds and grass has been cut around the tennis and bike park.

Signed an agreement with DHM to create conceptual designs of the forest service lot.

Bike Park Director Report

Crown has 2 electric bikes, 2 mountain bikes and a variety of dirt jumpers for the public to use at the park.

Hats are here and are for sale. We used the cost recovery continuum to determine fees for the hats.

BMX State is this weekend, we are uncertain about numbers for the race due to the I-70 closures.

BMX track has been getting tore up from Mountain Bike tires, we are considering limiting hours on the track to decrease wear and tear. Leroy mentioned we don't want to privatize anything at the park. Nate agrees.

Nate is working on sponsorships for 2022 and is looking at utilizing the athletic field space for sponsors.

Nate is working on recruiting more coaches for the bike park.

Nate is dialing in the maintanence staff needs for the bike park in 2022.

Leroy mentioned that Jenn has missed three unexcused consecutive meeting and according to state statue her position will need to be filled.

Becky mentioned that until minutes are approved in the September meeting; Jenn's 3rd unexcused absence isn't official.
