# 6:18 DHM Masterplan Design Discussion

Becky presents conceptual master plan to the board for the forest service lot. The plan includes parking a large pavilion with multipurpose space, walking paths, native grass and green spaces.

Next step is to understand the timeline for Eagle County to acquire the property.

The board directs Becky to have conversations with Eagle County on the conceptual design and there timeline for the property.

Mark would love to partner with Crown to operate the forest service building and get something going with AVSC and Crown. They are actively looking for space. Becky mentioned the building will be torn down if Crown doesn't have plans for it soon. Becky thinks we need to get together for a special meeting to talk specifically on the abandoned forest service building to see if this building is something the district can take on financially.

#### 6:45 Marchetti & Weaver Budget Overview

The board opened the public hearings for the 2021 amended budget and the 2022 budget. No public comment was presented. The hearings were continued until the November 10 regular meeting.

Mr. Erickson presented the 2022 preliminary budget. Discussion centered around costs associated with staff costs/wages, consulting, elections, and contract maintenance. Staff presented descriptions of the capital projects proposed for 2022.

Capital improvements budgeted for 2022 include:

Pavilion at the pond (Donated Ann Clapper)

Irrigation improvements and trees in the native for the ditch greenbelt

Bike Park improvements funded by park sponsors

Park amenities: picnic tables, trash cans, seating, grills, etc.

Improved parking lot at tennis with better walking paths

Adding Mid-valley metro sewer service onto the new shop

Major changes to maintanence at the park include increasing the landscape contract. Becky feels we need more help with irrigation management at the park.

Ted motions to do a continuation of the budget to be completed in November. All in favor.
