Ice Rink Update

- Colorado Extreme continues to add kids to the program (400 kids)
- Opening night learn to skate had 70 kids.
- Opening Saturday skate party had 150 people.
- Grizzly hockey is using the ice Monday-Friday after Colorado Extreme. Sheldon is giving them the ice for free until their chillers are up and running in Glenwood Springs. The cost to rent the ice rink is \$125/hr.
- Overall, the hockey program is a great success. The programming is incredible with (4) D1 hockey players
 and a navy seal coaching the program. These kids are not only learning hockey but skills they can use in
 life in the future.
- Blue Lake preschool has 30 kids using the ice throughout the winter for the learn to skate program.
- Public skate hours are posted on our website and updated weekly.
- We will not be putting up the shade shelter over the ice this year.
- Bathrooms and warming hut on the first floor are open to the public.

7:00 Eagle County & Crown Mountain PUD & Master Plan

Becky is recommending to the board to update Crown's PUD and Master Plan with Eagle County. The new MOU regarding the irrigation system with Eagle County currently conflicts with the existing lease agreement. In addition, Crown has made a variety of changes to the park over the years and an updated plan is needed to reflect those changes. Becky presented the master plan and would like to move forward with updating the plan.
